OR**

**10 small bags 10 to 29 gallons .**

**Must Pay by pound , .05 per lb**

**Furniture , Electronics , Constuction  
Or if you go over the limit of bags  
per week you must pay by pound .**

**Permits are for one house hold per  
permit .**
