

~~ORDINANCE FOR CLAY COUNTY PARK~~

Clay County provides these facilities for your convenience and enjoyment. Successful operation of this area depends upon your cooperation and compliance with the following rules and regulations:

1. Camping is on a first-come, first-served basis; except, an individual choosing a specific location must notify the manager by Thursday of the lot chosen for use the following week-end.
2. Camping is permitted at designated sites only. Maximum of 10 people, including visitors, and two camping units allowed per campsite.
3. Maximum of three vehicles may park at each campsite. Parked vehicles should not hinder traffic flow or cause safety hazards or site damage.
4. Camping stay is limited to days, so that the same individuals cannot stay in the same location for two consecutive week-ends.
5. Checkout time is 5 p.m.
6. Unless advance payment is made, unattended camping vehicles and equipment may not be left overnight and must be completely removed from site upon departure of camper. Clay County is not responsible for loss or damage of unattended equipment.
7. Visitors to registered campers are permitted between 7 a.m. and 10 p.m. After 10 p.m., basic camping fee is charged. Visitors should be in the company or at the campsite of the party visited.
8. Camping in a fee area without payment of designated fee is prohibited.
9. Place all garbage and refuse in trash cans or dumpsters.
10. Fires shall be confined to fireplaces, grills, or other appropriate facilities (where provided). Where no facility is provided, camper shall use reasonable care in handling campfires.

11. ~~Hang lanterns on lantern hangers or place on table. Hanging lanterns on trees is prohibited. The heat from the lantern will eventually kill the tree.~~

12. Do not cut, damage, pull up, or drive nails into trees or shrubs.

13. Respect your "camper" neighbors -- observe quiet hours from 10 p.m. to 6 a.m.

14. Firearms, fireworks, and alcoholic beverages are prohibited.

15. The operation or use of any noise-producing device, electronic or otherwise, in such a manner as to unreasonably disturb, annoy, or endanger persons is prohibited.

16. Recreational use of motorbikes within recreation area is prohibited. No motorized vehicle is allowed off the roadways, except for appropriate parking privileges.

17. All pets must be kept on a leash at all times and are prohibited at beach and adjacent sunbathing area.

18. REPORT ALL DISTURBANCES TO CLAY COUNTY PARK RESIDENT MANAGER OR PUBLIC SAFETY.

19. You can be fined up to \$50, and imprisoned up to 30 days in jail, for refusing to obey this ordinance; in addition, your vehicle or automobile may be towed and you shall be required to pay the towing fee to have your vehicle released to you.
